# Notes from the Director's Desk

it is a hot, busy time of year. We have a lot to look forward to in the near future. There are a lot of events going on that require an EMS presence. The weekly races at Lucas Oil and the El Dorado Springs Picnic are coming up. The new Education building is going up fast. I hear the tentative completion time is late this fall. At that time, we will be able to expand the Polk County Base into the current education area. Classrooms A and B will be used during ACLS, PALS and TNCC classes and may be scheduled for meetings. We will be able to expand into the offices and classroom C as well as have regular access to classrooms A and B. Theron and I are working on a process so the rooms can be scheduled. If you have ideas on how we can reconfigure the crew rooms and classroom C, let Aaron W or I know your ideas.

#### LEM (Leader Evaluation Manager)

LEM is how Managers up to Senior Leader are evaluated on their job performance. The development of LEM begins with strategic planning. Mr. Babb, the Board of Directors and the Senior Leadership team set goals based of the organization's strategic plan. Mr. Babb sets his LEM, the Senior Leaders develop their LEM based on the organization goals and Mr. Babb's LEM. The senior leaders meet with all of those that report directly to them and they develop their LEMS. In my case, I meet with Jeff. The LEMS have 4 areas of focus- all based on our flag poles (Service, Quality, People and Finance). Each goal is weighted and objective. Several weeks ago, all of those who directly report to Jeff met with him and Debbie Venacotter, our Studder coach. As a group, we discussed our LEMS. Our goal was to be sure all of our LEMS aligned. I then meet with all our Operation Managers and we develop their LEMS from my LEMS goals. This year, as in the past, our LEMS are very similar except they are focused on their specific operational area. Aligned LEMS lead us all in the same direction and help us as a department and organization to reach our goals. Once our LEMS are "locked", I will share my LEM with you and the managers will share their LEMs too.

1 am working on our Performance Center goals now. Performance Center Goals are developed off my and the Operation Mangers LEM. This year, goals will be individual based <u>and</u> county based. All of us will have our goals tied together. As we move forward, I will present the 2016 Performance Center to you. This year, we will do better communicating your performance center status. We will continue to have goals of overall satisfaction of the hospital competency completion and interdepartmental satisfaction. One of the new quality goals will be acquiring a 12 lead within 10 minutes of patient contact when the chest discomfort protocol is followed. We still have another goal we need to develop and we have a couple under consideration. We have to be sure the goals are objective and we can collect the information we need.

We continue to look for Paramedics. Bruce Goddard, FT Osceola, is working on his department orientation. We have 2 candidates that are in the hiring process.

In the coming months, during staff meetings, I will discuss the EMS operational budget and the capital budget. I receive frequent questions about the budgets and I hope I can shed some light on it.

We now have the lock box for narcotics available for paramedics to use in the left hand cabinet in the crew workroom. Now, if a supervisor is not available, paramedics can still lock the narcotics up when the trucks go to fleet or another county.

We have ordered new automatic blood pressure cuffs for the Lifepaks. We have also ordered a replacement case for one of the Lifepak 15. These purchases were all driven by rounding.

Speaking of Lifepaks, we have been approved to get one for Polk County. Once we receive it, we will see what other cases need to be replaced.

Also, we are approved for a new Stryker power cot as well as a stair chair to use with the new power cot.

We have talked about many of the things we need to upgrade. Our budget is fairly limited, so I want to remind everyone that we need to take care of the equipment we have. Equipment and bags are being left on scene. Other equipment is being broken and has to be replaced. All of this takes away from other things that we can purchase, so be careful and make sure we remember our equipment before departing scene and make sure we take care of it as if it is our own.

How is everyone's summer going? Are you enjoying the sun, fun and rain? I have been having a blast so far. I am excited to be diving once or twice a week while settling into the 24 hour shift life in ELDO. I took the summer off from college but I have been taking other classes. I am really looking forward to Dive Rescue Class in July.

I am writing this the evening after being at the leadership development class that CMH requires of all the **supervisors. The main thing I can report about is concerning the upgrades to CMH's email system. I was quite concerned** when I initially read the permissions that the new email server was requesting of the android operating system. The server wanted to be able to take over phone management of an android phone, and be able to a complete factory reset without notice to the operator. iPhones do not allow this and are not susceptible to it.

After reading that, and some careful thought, I removed CMH Email from my phone and tablet. I advised several to not allow that kind of access to someone else. I don't intend any disrespect to anyone, but accidents and Mondays happen. We all have lost charts on HealthEMS, pictures from phones, schedules, notes, and emails. I didn't want to lose personal information off my phone.

At LDI today, Chief Information Officer Denni McColm offered several email tips and tricks in her presentation. Here is a link to that presentation from a CMH computer <u>\\appsrv-4\cmhdata\Depts\All\_Depts\Studer Group\LDIs\JUNE</u> 2015\email tips and tricks LDI.ppt The material she presented was similar to "Getting things Done" by David Allen and "Inbox Zero" by Merlin Mann. Both of these are processes that I use to keep me on track and they really help.

The third point of her presentation is what I want to bring to you. It was concerning the android permissions. Denni told all the hospital supervisors that she was not comfortable with that permission and then she presented an alternative android app that would allow you to have CMH email and not have to allow those permissions.

Another option presented was using your phone/tablet mobile browser to go to www.citizensmemorial.com click on employee resource link, and the Outlook web app link. I find that hard to do and hard to read, hence my recommendation for an app.

Denni did make a good point. There might be a point in time where you would want someone to have that permission. Say for instance, your phone is stolen, or you lose your phone, at work even, and you have no idea where in the last 600 miles and 12 hours you lost your phone. CMH LS. could completely wipe your phone remotely for you so that a thief could not steal your personal information. This is an interesting idea anyway. I sent out an IRIS, and then a CMHEMS email that presented a link to that app. It is <a href="https://goo.gl/wiDv9X">https://goo.gl/wiDv9X</a> and it **does not** require those permissions. This made me more comfortable about having CMH email on my personal items. Within minutes, I added it back to my phone and tablet. The settings are the same as before.

- Select Microsoft Outlook Exchange and when prompted, enter your email address and password.
- Click on advanced settings, put your username where it asks for it. For instance, mine is ryoung.
- After that, enter webmail.citizensmemorial.com for server address.
- The domain is domain1.
- Then, simply click okay.

I am sure Theron will help you with it if needed, and I will help you as well. There are several other tech savvy folks around that lay low who may help as well.

The next thing I wanted to talk about this month is back to our favorite topic- patient documentation with HealthEMS. The Coding and Billing Departments have asked that we double check our work. There are three things on every call that need to be verified: (1) the incident location,(2) the destination location, (3) and the mileage. These 3 items have to be correct in every location on the trip ticket.

After that, I want to remind you of the three things on every intrafacility transfer that **must** be included in our documentation. (1) Why was the patient seen at the incident location, (2) what was the diagnosis from the provider, and (3) why do they have to ride with you in an ambulance. On this item, you may very well be documenting "no other transportation available." On the PCS form, this will be check marked on Box 19.

Finally, the last HealthEMS item is to **please** make certain your charts export. We are aware of the home/residence issue that creates a critical notification but you are still responsible to export the report **by the end of your shift. Don't forget** to click the globe to check for charts that are located on other computers. <u>All</u> charts must be exported by the end of your shift.

Now, for some good news. I anticipate during the third week of July, I will be updating to the next version of MobileEMS. This update will include several bug fixes. One of them is the home/residence turning into a critical (red) error. Next month, if I have space in my newsletter, I will share the rest of the updates with you.
