February Fun Facts!!

February comes from the Latin word *februa*, which means “to cleanse.” The month was named after the Roman *Februalia*, which was a month-long festival of purification and atonement.

February is the only month with less than 30 days

Adding an extra day every 4 years keeps our calendar aligned correctly with the astronomical seasons, since a year according to the Gregorian calendar and a year according to the Earth’s orbit around the sun are not the same exact length of time. Without this extra day, our calendar and the seasons would gradually fall out of sync. Because of the extra day, a leap year has 366 days instead of 365. Additionally, a leap year does not end and begin on the same day of the week, as a non-leap year does.

The next Leap year will be Thursday, Feb 29, 2024

Feb 12 is Lincoln’s Birthday

Feb 14 is Valentine’s Day

Feb 15 is Susan B Anthony’s Birthday

Neal's Thoughts

The Paramedic class is reading Thom Dick's book *People Care* and they have an email thread for discussion. I am impressed by what I read. *People Care* in my opinion is the non-clinic text book for EMS. When we take care of patients, we see them at their worst. We are called because they need help. Our goal should be to provide each one of our patients exceptional, compassionate care in the situation and environment they are in. Thom's book dives into this part of EMS. He also talks about how FTOs affect new staff and students. It talks about compassion and should be a gut check for any EMT or Paramedic. Why do you do EMS?

We recently reviewed the results of an audit by Page, Woldberg and Wirth, PWW that was completed on some of our PHS Patient Care Records. They looked at our PCR for compliance. Areas we scored highly deficient in are:

Valid patient signature and valid reason the patient could not sign.

Documentation must provide information to support medical necessity.

You can help by getting the patient's signature for permission to treat and transport and the privacy statement signed. If the patient cannot sign or has difficulty signing there is a drop down box you need to use to document why they cannot sign. You should now be using the DRATT narrative format. Help sheets are in each station

You need to include in your narrative:

What do you observe on scene and about the patient?

Where did you find the patient what position is the patient in

What is going on with the patient?

What does the patient look like



Neal's Thoughts (continued)

Document your full assessment

What treatment was done during transport?

Changes after transport treatments.

How was the patient upon arrival at the facility?

Who was report given to

Valuables: what was done with them if any.

Your narrative must tell the story and have, details, details and more details.

Remember on any transfers:

What is the Diagnosis? Not what the nurse told you but what is on the transfer papers.

Why was the patient in the hospital? Why did the patient come to the ER?

What, if any, treatment was done at the sending facility?

Steve Keller has begun to review our PCR for compliance and the use of the DRATT format.

You will be getting emails or notices from Steve on the corrections you need to make on your PCR.

Our goal is to improve our documentation to have a high quality record of our patient care. If we produce high quality documentation the by product is a PCR that is easier to code for billing and a PCR that looks good and is professional if subpoenaed or requested by an attorney.

The go live date for ESO EHR is April 1. We will have training in March, please stay tuned for training dates and times. Changing PCR is a big deal but the change to ESO will be worth it.

I recently became a Certified Ambulance Documentation Specialist. I would like to address a few things with all of you in hopes to facilitate us in becoming better documenters. First, I would like to say the better your documentation is, the more we are reimbursed and our patients are billed more accurately. To become a more accurate documenter, your documentation needs to be accurate, needs to be subjective, NOT objective...meaning, facts need to be in the report and NEVER your opinion. Now, when I say the document needs to be accurate, I am talking about specifics. For example, do not just write "hip fx". Which hip was fractured? The left? The right?

We are recommending the DRATT concept when writing a narrative. Please refer to the cheat sheets that we have available as to what information goes under which heading. Remember, the better the documentation, the better the reimbursement or the less likely the patient will be overcharged.

I really do appreciate everyone that has picked up extra shifts. We rarely have been forced to shut down a truck. As well, we have the U shift up and running more often then it is shut down!! Strong work guys!!

Health & Safety Tips from Brice

I just want to pass on some updates regarding 706. Everyone in Polk County has worked out of 706, the newest remount truck with a forward facing attendant seat on the curbside. I think it is working out very well since we have started using 91 octane fuel. We did have one issue with the initial design, where the second trauma patient should be transported.


The remount company moved a mount higher up on the wall to make securing the backboard more simpler. The issue was then, how do we attach the backboard so that it will not move during transport. With the insight of Lucky and Comorgan, the issue has been addressed, and I think resolved.

See the attached picture and how the straps are crossed from the wall, through the backboard, and down to the floor mounts. This board placement is very secure, and I recommend a similar approach when using a backboard on a bench seat.
