Individual assignment to meet education and competency requirements:

- You are all caught up with licenses and certifications.
- Complete the protocol quiz each month with at least an 80%. The Feb 2021 quiz will be the first one where you can take it multiple times until you pass it. The Mar 2021 quiz will be the first one where you will be removed from the schedule if you do not pass it.
- Attend Life Support Competency in October each year. However, you will expire before then, so the next competency you need to sign up for is 8/17/2021.

Attend the Feb STEMI competency for the date/time you signed up for. If you do not attend the Feb 2021 competency, you will be assigned a written test. Look for, sign up for, and attend the ventilator competency in June. The Jun 2021 competency will be the first one where you will be removed from the schedule if you do not attend and pass the written test

Attendance to competencies and maintaining licenses and certifications is required by job description and policies. However, the incentive for sustaining these minimum requirements has only been a small increase in annual evaluations.

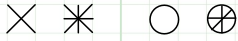
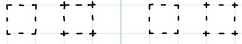
Right now, 14% of the PHS employees have met the requirements of competency attendance and certificates on file. This is obviously a problem.

After discussions with administration, medical director, and human resources, we have developed a plan to address these deficiencies. All the details of the new guideline and process can be found here: <http://ozarksems.com/protocol-1-500.php> and summary below.

To be eligible to be on the schedule for ambulance shifts, the following must be met.

- Licenses and certifications must be on file. I will send out individual emails today to everyone listing what we have on file for you.
  - EMT or paramedic license,
  - Class E or better driver license,
  - AHA BLS,
  - FEMA NIMS 100, 700, & 800,
  - TIMS,
  - EVOS,
  - PHTLS,
  - Medics only:
    - AHA ACLS,
    - AHA PALS,
    - FEMA NIMS 200
- 100% competency attendance. Each competency has remediation options.
  - Attend four in-person competencies each year.
    - Annually, attend the life support competency that is due during your birthday month. If you need them, you will also get your AHA certifications for attending. Offered every second Tuesday. Remediation is in Springfield the Friday after the original event. The March 2021 Life Support Competency will be the first one where we will remove people from the schedule that need to attend and do not.
    - Each trimester (three times per year), attend the education and competency event. Each event is offered five times over two weeks just like we have been doing that include daytime and one evening event. Remediation is a difficult written exam due within two weeks after the last event. The June 2021 PHS Competency will be the first one where we remove people from the schedule for not attending and not completing remediation.
    - Monthly, successfully complete the protocol quiz. You can attempt the quiz as many times as required to attain a passing score of 80%.
