-CMH on track to be a Level 3 Stroke Center, probably in December.

-Recruit any and all EMTs and Medics that you can.

-Make sure you are checking PCS forms at the hospital before you transport and get corrected if needed. If hospital staff give you trouble, contact one of your leadership team.

-If you have handheld radios at home please bring them back to the Bolivar station.

-Charts have to be done within 24 hrs, get them locked before the end of your shift.

Read your emails. CMS issued its anticipated regulation mandating the COVID vaccines and CMH policies will change to require it to stay in line with CMS because 60% of operating funds comes from those payments. CMS interim final rule set a deadline of Dec 5th 2021 to get a first dose. CMS is requesting public comments about their regulation for 60 days. Declaration forms for exemptions have been emailed out for the COVID shots.
