CMS issued its anticipated regulation mandating the COVID vaccines and CMH policies will change to require it to stay in line with CMS because 60% of operating funds comes from those payments. CMS interim final rule set a deadline of Dec 5th 2021 to get a first dose. CMS is requesting public comments about their regulation for 60 days.
