If you wish to decline receiving the COVID-19 vaccine, we are requiring that you let us know by completing a request for exemption or declination. The deadline for submitting accommodation requests including religious exemption, medical exemption or vaccination declination, is extended to Wednesday, Dec. 15, 2021.

It should be noted that in the event the preliminary injunctions are overruled and CMS once again requires all health care workers to be vaccinated, the declination form will not meet the standards for exemption.
